



To what extent you agree with the level of qualified and experienced faculty members.





To what extent youagree with the level of co-curriculum activities, workshop, seminar and events.









To what extent you agree with level of quality of teaching methodology, theoretical knowledge of faculty members










To what extent you agree with the level of behavior of faculty members.



To what extent you agree with the level of use of latest technology.


